II. All the members analyzed the results in detail that is


- For B.Tech grafting are applied for regular exams in result processing.
- Overall pass percentage of **I-B.Tech I-Sem (R25) Regular** results are 49.1%
- Total students were benefited by using Grafting is 47
- Overall pass percentage of **I-B.Tech I-Sem (R22) Supply** results are 11.14%
- Overall pass percentage of **I-B.Tech I-Sem (R20) Supply** results are 4.48%
- Overall pass percentage of **I-B.Tech II-Sem (R22) Supply** results are 17.35%
- Overall pass percentage of **I-B.Tech II-Sem (R20) Supply** results are 5.71%
- No subject’s moderation applied and Grafting rules are applied in Regular result processing.
- No subjects moderation and Grafting rules are not applied in supply result processing.
- Overall pass percentage of **II-M.Tech I-Sem (R22) Regular** results are 73.68%
- Overall pass percentage of **II-M.Tech I-Sem (R22) Supply** results are 60%

2. Double valuation is followed in evaluating answer scripts of end semester examinations. The procedure for finalizing raw marks is given below:
  - i. The average of the first and second valuations will be taken for award of marks, if the difference between first and second valuation is less than or equal to 11 marks (0.15% external Marks).
  - ii. In case, the difference of the marks obtained in the two valuations is more than 11 marks then a third examiner shall evaluate the scripts.
  - iii. Out of the three valuations, the average marks of any two valuations which are closer and the difference between them is less than or equal 11 marks, the closest average marks is considered as final marks.

IV. Evaluation Procedure for R22 & R25 Regulation:

1. The evaluation procedure has been carried out through online evaluation.
2. Double valuation is followed in evaluating answer scripts of end semester examinations. The procedure for finalizing raw marks is given below:










- i. The average of the first and second valuations will be taken for award of marks, if the difference between first and second valuation is less than or equal to 9 marks (0.15% external Marks).

- iii. Out of the three valuations, the average marks of any two valuations which are closer and the difference between them is less than or equal 9 marks, the closest average marks is considered as final marks.
