The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following.(The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER

This Application is filed seeking a direction to the respondents to consider the representation dated 17.06.2026 of the petitioners-institutions and comply with the common order dated 12.06.2026 passed by this Court in W.P.No.17863 of 2026 and batch.

Heard Mr. S.Sriram, learned Senior Counsel representing Mr.Kaustubh Akkiraju, learned counsel for the petitioners, and Mr. G.Chandra Shekar Reddy, learned Standing Counsel for Telangana Admission and Fee Regulatory Committee (TAFRC).

Learned Senior Counsel appearing for the petitioners submits that for the block period 2025-28, the petitioners-institutions proposed a fee of Rs.1,20,000/- in W.P.No.19900 of 2026, Rs.2,00,000/- in W.P.No.19910 of 2026, Rs.2,00,000/- in W.P.No.19932 of 2026, Rs.1,50,000/- in W.P.No.19981 of 2026, Rs.1,65,000/- in W.P.No.19990 of 2026, Rs.1,60,000/- in W.P.No.19996 of 2026 and Rs.1,75,000/- in W.P.No.20005 of 2026, for B.E./B.Tech course. After considering the proposals and conducting personal hearings on 27.02.2025 and 03.09.2025, initially the TAFRC determined higher fee structures of Rs.1,15,000/- in W.P.No.19900 of 2026, Rs.1,75,000/- in W.P.No.19910 of 2026, Rs.1,45,000/- in W.P.Nos.19932 and 19996 of 2026, Rs.1,45,000/- in W.P.No.19981 of 2026, Rs.1,42,000/- in W.P.No.19990 of 2026, Rs.1,55,000/- in W.P.No.20005 of 2026 for B.E./B.Tech course. However, thereafter, the Government issued G.O.Ms.No.6 Higher Education (EC) Department, dated 04.03.2026 notifying substantially reduced fees of Rs.76,100/- in W.P.No.19900 of 2026, Rs.72,300/- in W.P.No.19910 of 2026, Rs.99,800/- in W.P.No.19932 of 2026, Rs.70,000/- in W.P.No.19981 of 2026, Rs.78,100/- in W.P.No.19990 of 2026, Rs.79,700/- in W.P.No.19996 of 2026 and Rs.91,200/- in W.P.No.20005 of 2026 per student per annum, without assigning any reasons or issuing further notice or affording an opportunity of hearing to the petitioner institutions. Accordingly the petitioners approached this Court and pursuant to the order, dated 12.06.2026 passed by this Court in W.P.No.17863 of 2026 and batch, whereby the petitioners-institutions were directed to file fresh applications and TAFRC was directed to

reconsider their cases for fee fixation, the petitioners-institutions submitted representation, dated 22.06.2026 setting out detailed objections to the fee fixed under G.O.Ms.No.6, dated 04.03.2026 and to the working sheets adopted for computation of fee. He further submits that the said representations are pending for consideration and the counselling has already commenced.

On the strength of the above submissions, learned Senior Counsel prayed this Court to permit the petitioners-institutions to collect the fee fixed for the previous block period i.e., A.Y. 2022-23 to 2024-25 i.e., Rs.80,000/- in W.P.No.19900 of 2026, Rs.95,000/- in W.P.No.19910 of 2026, Rs.1,10,000/- in W.P.No.19932 of 2026, Rs.75,000/- in W.P.No.19981 of 2026 Rs.1,10,000/- in W.P.No.19990, Rs.1,05,000/- in W.P.No.1996 of 2026 and Rs.1,15,000/- in W.P.No. 20005 of 2026, subject to the afresh consideration of the TAFRC and further requested this Court to direct the Convener, TGEAPCET, to display in the official website and communicate to the prospective students seeking admission into the petitioners-institutions that the said fees may be increased subject to the further orders passed by the TAFRC.

On the other hand, learned Standing Counsel for TAFRC opposed the grant of interim relief to the petitioners-institutions on the ground that the representations dated 22.06.2026 is still pending for consideration.

Having regard to the submissions made by the learned Senior Counsel appearing for the petitioners, and considering the fact that the counselling process has already commenced, as an interim measure, this Court is inclined to issue following directions:

(i) The petitioners-institutions are permitted to collect the fee fixed for the previous block period i.e., A.Y. 2022-23 to 2024-25 i.e., Rs.80,000/- in W.P.No.19900 of 2026, Rs.95,000/- in W.P.No.19910 of 2026, Rs.1,10,000/- in W.P.No.19932 of 2026, Rs.75,000/- in W.P.No.19981 of 2026 Rs.1,10,000/- in W.P.No.19990, Rs.1,05,000/- in W.P.No.1996 of 2026 and Rs.1,15,000/- in W.P.No. 20005 of 2026 for the A.Y. 2026-27, subject to the afresh consideration of the TAFRC.

ii) The Convener, TGEAPCET, is directed to display in the official website that the fees to be collected per student is Rs.80,000/- in W.P.No.19900 of 2026, Rs.95,000/- in W.P.No.19910 of 2026, Rs.1,10,000/- in W.P.No.19932 of 2026, Rs.75,000/- in W.P.No.19981 of 2026 Rs.1,10,000/- in W.P.No.19990, Rs.1,05,000/- in W.P.No.1996 of 2026 and Rs.1,15,000/- in W.P.No. 20005 of 2026 and the said fees may be increased subject to the afresh consideration of the TAFRC.

(iii) The Convener, TGEAPCET shall communicate the above order to the prospective students seeking admission for the A.Y.2026-27 into the petitioners-institutions.
